Lawmakers Eye Limits On Qualified Immunity For Law Enforcement

Illinois State legislators are considering eliminating or limiting aspects of qualified immunity for law enforcement. With this on the table, let's take time to better educate the public on the myths and facts of Qualified Immunity.



What is Qualified Immunity?

Qualified immunity applies only in civil lawsuits where a state actor (i.e. police officer or government official) is sued in his or her individual capacity for performing a discretionary function and the plaintiff seeks monetary damages directly from the state actor.

Qualified immunity is an affirmative defense available to state actors, and, if granted, provides them protection from personal, civil liability.



What Qualified is NOT:

Qualified immunity does not protect those that "knowingly violate the law." In cases where it is obviously, or sufficiently clear, that the officer or government official's conduct was unlawful, qualified immunity is unavailable and the case will proceed to trial.

Qualified immunity does not prohibit suits against the city, municipality, or other government entity itself.
