HOW TO MAKE YOUR VOICE HEARD

Attention Illinois Citizens (HB163, Amendment 2):

The Illinois Law Enforcement Coalition was not consulted on HB163 nor did we have any input before the bill was filed. We continue to be opposed to the bill.

Over the last two days we have had conversations with the bill's sponsors but we have not agreed to any revised language regarding the bill because it is inappropriate to try and ram through such drastic legislation during the Lame Duck session.

We are not opposed to police modernization and continue to be willing to sit down and work through the issues during the spring session when there is time to consult with all parties involved and find some common ground. Many of the issues are complicated and need thorough legal review. This issue is too important and far-reaching to rush something through the General Assembly in the next few days. To do so is a recipe for disaster.

Time is of the essence. Please continue to contact your legislators and inform them of your opposition to this bill. Also please submit a witness slip before Saturday at 9 a.m. in opposition to this bill. Here is how you can do that:
