2025 CYCLE ACROSS ILLINOIS

Honors Fallen Heroes with 380 - Mile Tribute Ride

This past weekend, dozens of cyclists journeyed across the state in the 21st Annual Cycle Across Illinois, a powerful four-day event honoring Illinois police officers who lost their lives in the line of duty. The ride began Friday morning in Champaign and concluded in Chicago, covering more than 380 miles and passing through communities where fallen officers had served. At each stop, riders paused to honor the memories of these heroes, offering tributes and connecting with the families and communities forever changed by their loss.

Organized by the Illinois Chapter of Concerns of Police Survivors (C.O.P.S.), the event served as a moving reminder that the sacrifice of law enforcement officers is never forgotten. Each mile cycled was a show of support, not just for the fallen, but for the survivors they leave behind.

Illinois C.O.P.S., a nonprofit organization, provides year-round support for families of fallen officers, offering everything from counseling and peer support to legal guidance and financial assistance. Their dedicated team responds to every line-of-duty death in the state, providing immediate and ongoing help to those who need it most.






2025 ISA Get to Know Your Sheriff Series - July | Douglas County



GET TO KNOW YOUR SHERIFF - Douglas County

What first made you get involved with law enforcement?

As long as I can remember, I have been attracted to law enforcement through the positive experiences I had with local police officers and deputies growing up. After college I was fortunate enough to get the

opportunity to get into a field where I could be the positive influence while serving the same community that had given me so much.



Describe your role as Sheriff in your Office and throughout your County:

I oversee operations within the Sheriff's Office, including a patrol division, a county-wide telecommunications center, act as warden of the County Jail, and oversee security and maintenance of the Douglas County courthouse. I also work to provide services to reduce recidivism by partnering with local social service and treatment groups.



What is your favorite part about being Douglas County Sheriff?

I get the honor of representing and leading nearly 40 employees that give their all in the interest in protecting and serving the residents of Douglas County. It is a joy to see their growth and impact in the community.





Describe what drives you to get involved within the community:

I have been elected to a position that allows me to directly affect the community that I grew up in myself. Not many people are fortunate enough to have that opportunity, and it is important to me to understand the impact I can have and not to squander it.



What's the best thing to happen to you because of your community or career in peace keeping service?

Seeing the positive outcomes firsthand from my time as a Correctional Officer later as a Deputy. I also served as a DARE and a School Resource Officer. And now, as Sheriff, I have been able to place my staff in positions to flourish and grow. It is very rewarding.











Tell us about someone or something that has influenced you:

Recently DJ Daniel, a young man facing many medical challenges who is succeeding despite the hand he has been dealt. He is using his time to share positive messages and build bridges between communities and their law enforcement agencies when he easily could be doing anything else. I find him very inspiring.



What do you consider the biggest challenge in your community?

Recent changes to some of our laws in Illinois have created challenges in getting services for people that are greatly in need of them. What used to be a short jail stint where we could link offenders up to services to help them get clean and not reoffend are now, in most cases, cite and release. I have a hard time believing that was the intent, but it is creating a cycle of more repeat offenders, which is in turn creating more victims.



time would describe you?

I hope I give the impression of someone that is straightforward and rational. I am very principled when it comes to doing what I believe to be the right thing.



What advice would you give young people?

Be willing to get out of your comfort zone and take calculated risks. Don't be afraid to fail. I would have lost out on many opportunities in my career and in life had I not taken some chances.
