


## The Illinois Sheriffs' Association (ISA) is proud to announce DuPage County Sheriff's Office K9 Xena and her handler, Deputy Aaron Davis, as the 2026 ISA K9 Hero

Launched in 2024, the ISA K9 Heroes Program was created to celebrate the remarkable service and sacrifice of police K9s and their handlers across Illinois. Each year, sheriffs' offices are invited to nominate their K9 teams for recognition. These highly trained dogs assist in narcotics detection, search and rescue, suspect apprehension, and community outreach - serving as both protectors and ambassadors of public safety.

This year's nominations featured eight K9s from seven counties, each demonstrating extraordinary commitment to service. After reviewing years of service, deployments, and accomplishments, ISA selected K9 Xena, a six-year-old Chocolate Labrador Retriever, for her exceptional work in narcotics and human remains detection.

As part of the K9 Heroes Program, ISA will launch a limited-edition K9 Xena plush toy and trading card this fall through the ISA Holiday Store at the end of October. For a \$30 donation, it will include the collectible plush fitted with tactical vest, sheriff collar, and Hero dog tag. Net proceeds will directly support the DuPage County K9 Unit in honor of Xena's service.



#### **Accidental Payment & Overpayment Scams**

At first glance, "accidental payments" might seem harmless. You receive money you didn't expect, perhaps via a payment app, bank transfer, or in connection with an online sale. But in many of these cases, that "mistake" is the first move in a scam.

In an accidental payment scam (sometimes called "accidental deposit scam" or "overpayment scam"), a fraudster sends money, often via stolen funds, to a victim's account as a setup. They then contact the recipient claiming it was a mistake and ask them to "return" the extra money. The catch:

the original deposit is fraudulent or reversible (the bank can claw it back), and if you send money back, you might be sending *your own* funds, leaving you at a loss.

One variation occurs in online marketplaces or peer-to-peer selling: a buyer "accidentally" sends too much, then asks for a refund of the difference. The buyer's original payment is bogus, but you may already have sent the "refund."

#### **Red Flags & Warning Signs**

Here are several warning signs you should watch for:

- You receive a payment from someone you don't know or weren't expecting.
- The sender contacts you urgently, insisting the overpayment be returned immediately.
- They pressure you not to verify with the app or bank.
- Their "refund request" asks you to use a risky or untraceable method (gift cards, cryptocurrency, wire transfer, etc.).
- The original "payment" shows as pending, later reversed, or fails verification.
- The messaging is emotional or manipulative: "I'm in trouble," "It was a typo," or "Please help me right now."



#### What You Should Do (and Not Do)

- Don't send money back, at least not immediately. Wait until your bank or payment app confirms the original transaction is valid and settled.
- Contact the payment app or bank directly. Use official support channels—not the contact information sent within the message from the supposed sender.
- Report suspicious transactions or messages. Many apps have "report fraud/unauthorized activity" options.
- Document all communications. Save messages, screenshots, any emails or texts. This
  helps if you need to dispute or report later.
- Be skeptical, even when it seems harmless. If something feels off, pause and verify.

Scammers are crafty, but with a little awareness, you can outsmart them. If something feels off, especially when it comes to money - trust your gut!

<u>Here's a scary statistic</u>: Children are <u>more than twice as likely</u> to be hit by a car and killed on Halloween than on any other day of the year. Lack of visibility because of low lighting at night also plays a factor in these incidents.

#### Keep these tips in mind when your children are out on Halloween night:

- A responsible adult should accompany young children on the neighborhood rounds
- If your older children are going alone, plan and review a route acceptable to you
- Agree on a specific time children should return home
- Teach your children never to enter a stranger's home or car
- Instruct children to travel only in familiar, well-lit areas and stick with their friends
- Tell your children not to eat any treats until they return home, and take care to avoid any food allergies
- Watch for cars that are turning or backing up. Teach children to never dart out into the street or cross between parked cars.
- Have kids carry glow sticks or flashlights to help them see and be seen by drivers
- Choose face paint and makeup whenever possible instead of masks, which can obstruct a child's vision

Additional safety tips for parents – and anyone who plans to be on the road during trick-or-treat hours:

- Watch for children walking on roadways, medians and curbs
- Enter and exit driveways and alleys carefully
- Popular trick-or-treating hours are 5:30 p.m. to 9:30 p.m. Be especially alert for kids during those hours.
- Discourage new, inexperienced drivers from driving on Halloween
- Turn your headlights on earlier in the day to spot children from greater distances
